GENERAL POSITION SUMMARY

The Southeast LA (SELA) Community Organizer will be responsible for conducting educational outreach and recruitment, developing liaisons with grassroots leaders and allies, representing the organization in coalition spaces, advancing leadership and membership development and leading grassroots environmental justice and civic engagement campaigns. The SELA Community Organizer will be primarily focused on Clean Transportation and Energy; local SELA and statewide environmental justice issues and the "cumulative impacts" of goods movement, air pollution and contamination of soil and EJ Advocacy work locally and in Sacramento.
