### SCOPING PLAN FAST FACTS



- It is California's plan to address climate change. Every 5 years, the California Air Resources Board (CARB) leads Scoping Plan adoption, & must complete this one in 2022.
- Climate change is caused by greenhouse gases (GHGs), which absorb sun & heat the planet. They include CO2, methane, and more, from burning gasoline & diesel in cars & trucks, oil refineries, oil-drilling, gas-fired power plants, and more. (Agriculture is another big source.)
- <u>Climate Change is causing deadly heatwaves, wildfires, droughts,</u> floods, melting ice caps, ice storms, & much more.
- If we don't stop using dirty energy (and ramp up clean energy), the planet can become uninhabitable in many places. We are running out of time.
- CBE, CEJA (the California Environmental Justice Alliance) and many Environmental Justice organizations are taking part in the Scoping Plan.
- CARB staff published a weak proposal that can cause major harm to environmental justice communities ("Alternative 3"). See our asks on back!

WHAT SHOULD WE ASK FOR THE SCOPING PLAN?

#### OIL REFINERIES

- We need a plan to <u>PHASEOUT</u> REFINERIES BY 2045
- Electric Vehicles & Public Transit must be increased at the same time
- CARBON CAPTURE AT
   REFINERIES IS AN EXCUSE TO
   PAD BIG OIL PROFITS It also
   isn't possible to cover hundreds of
   stacks at crowded refineries, and
   can increase explosion hazards!

#### OIL-DRILLING/ EXTRACTION

- ALL OIL EXTRACTION ACTIVITIES

  SHOULD BE PHASED OUT IN

  CALIFORNIA BY 2035
- Between now \( \) 2035, no new extraction permits should be granted
- JUST TRANSITION programs should be created to help transition workers to well-paid, non-polluting union jobs

#### TRANSPORTATION

- CARB must move aggressively to phase out Internal Combustion Engine new car sales by 2035
- By 2030 more than 75% of new car sales should be zero emission
- 100% of truck sales should be zero emission by 2035
- Set aggressive targets statewide to increase transit & create communities that reduce reliance on cars

#### **ELECTRICITY**

- WE NEED TO PLAN FOR ZERO: The plan allows Power Plants to keep emitting 30 Million GHG Tonnes forever
- WE CAN'T BURN OUR WAY TO A
   CLEAN FUTURE: the plan calls for
   IO,000 new megawatts of gas-fired
   electricity, when 78% of these polluting
   plants are in EJ communities and would
   likely expand there
- WE DON'T NEED CARBON

  CAPTURE: we can get to Zero

  Emissions with Solar, Wind, Storage, &

  Demand Response

WE NEED a just transition with a robust fossil fuel safety net for workers & communities, with wage replacement and benefits in addition to retraining services for workers and a rainy day fund for communities in a toxic relationship and financially dependent on Big Oil.
